Emergency Vehicle Management Section Bylaws

(Formerly Apparatus Maintenance Section)

February 2023

Section One – PURPOSE – The purpose of the Emergency Vehicle Management Section (EVMS) of the International Association of Fire Chiefs (IAFC) is to provide a forum for all members of the Association who share common interests and concerns about Fire, EMS and Emergency Service Equipment and Emergency vehicles. Specific interests of the section include but are not limited to:

- National Certification of Emergency Vehicle Technicians
- Promoting Training and Education regarding Equipment and Emergency Vehicles
- Exchange and Distribution of Information regarding Equipment and Emergency Vehicles
- Addressing regulatory proposals, legislative processes, or federal policy initiatives that affect Emergency Equipment and Emergency Vehicles
- Collaborating with the Emergency Equipment and Emergency Vehicle industry for products that are in the best interest of the IAFC membershipfire service

Section Two – COMPATIBILITY WITH IAFC – Nothing in these bylaws shall be construed to be in conflict with, or take precedence over, the established Articles and Sections of the Constitution and Bylaws of the IAFC. Should a question of conflict arise, the matter will be referred to the Constitution, Bylaws and Resolutions Committee of the IAFC and, if necessary, to the Board of Directors for a final resolution.

Section Three – MEMBERSHIP – The membership of the EVMS will be open to any Regular, Associate, Departmental, Affiliate, or Life Member of the IAFC who shares an interest in the issues of the Section as set forth in its purpose. Only those members who are not eligible for Regular IAFC membership may join as Affiliate Members. Full membership in the IAFC is a requisite for membership in the Section, and failure to maintain IAFC membership causes an individual to lose membership in the Section.

Any member who is in good standing with the EVMS may be on the board of directors.

Section Four – DUES – The annual dues for Regular, Associate, and Affiliate members of the IAFC will be \$25.00 per year. The dues will be payable in conjunction with the payment of the members' Association dues.

Corporations are allowed to make donations to support the aim of the Section based upon approval by the IAFC Board.

Section Five – BOARD MEMBERS and OFFICERS

BOARD MEMBERS

The Section Board will consist of 10 members. The 10-member Board of Directors will be elected for three-year terms. These terms will be staggered so that the terms of the members of the Board expire as follows:

Year 1 – Great Lakes, At-large, Federal-Military, Southwestern

Year 2 – Eastern, New England, Canadian

Year 3 – Western, Missouri Valley, Southeastern

One member will be elected from each of the eight divisions of the IAFC:

- 1. Canadian
- 2. Eastern
- 3. Great Lakes
- 4. Missouri Valley
- 5. New England
- 6. Southeastern
- 7. Southwestern
- 8. Western

The ninth member will be elected from the membership at-large.

The tenth member will be elected from the Federal & Military Fire Services Section.

Board members must be a Regular, Affiliate or Life member.

A Secretary and Treasurer of the Section will be elected from and by the Board of Directors for two-year terms in even years. The Board members so elected may serve more than one term.

Any member elected to the Board who resides within the geographic boundaries of a Division and moves from that Division's area may complete that two-year term in office as the representative from that Division.

The Board of Directors will fill any vacancies by a simple majority vote.

OFFICERS

The Officers of the Section will consist of the Chair, Immediate Past Chair and Vice-chair.

A Vice-chair of the Section will be elected by the Board of Directors for a two-year term.

The member elected as Vice-chair will become Chair for a term of two years at the end of their_term as Vice-chair.

The outgoing Chair shall serve as the Immediate Past Chair for a one-year term. In the event that the outgoing Chair's term on the Board coincides with the expiration of the term as Chair, the outgoing Chair shall serve a non-voting one-year term as Immediate Past Chair on the Board.

Officers must be regular members as defined in Article II, Section 3(b) of the IAFC Constitution and Bylaws.

The Board of Directors will fill any vacancies by a simple majority vote.

Section Six – MEETINGS AND ELECTIONS –The EVMS will meet a minimum of once a year. The annual business meeting of the Section will take place at the annual conference of the IAFC.

Quarterly board meetings will occur via teleconference as scheduled in attachment one. The times and dates listed in attachment one may be changed by a simple majority vote of the board of directors. Leave this section for the following year's review.

The EVMS Board will hold other meetings at its discretion.

No later than 90 days before the annual meeting of the Section, the Chair will appoint a three-person Nominating Committee, all of whom will be members in good standing of the Association and Section. The Nominating Committee will publish and distribute its slate of nominations to all members in good standing not less than 30 days before the annual meeting. Election of Officers will be conducted by electronic ballot using the same procedures as elections for IAFC Officers at least 30 days prior to the annual meeting. All officers shall be elected by a simple majority of the votes received in electronic balloting of members.

Section Seven – QUORUM – A simple majority of eligible voting members who are present will constitute a quorum for the transaction of business at all meetings of the Section.

Section Eight - ORDER OF BUSINESS – The following Order of Business will govern all meetings of the Section unless suspended by a simple majority vote of the members present at the meeting:

- Call to Order
- Any Requests to Revise the Published Agenda
- Review and Adoption of Minutes of the Previous Meeting(s)
- Treasurer's Report
- Reports from Officers
- Committee Reports

- Program and/or Presentation(s) from Guests
- Business Agenda
 - -Old Business
 - -New Business
- Election of Officers (If Appropriate)
- Selection of Date, Time, and Location of Next Meeting
- "Good and Welfare" of the Section
- Adjournment

Section Nine – RULES OF ORDER – The EVMS will conduct all meetings in accordance with the provisions of *Robert's Rules of Order Newly Revised*, except where the Rules of Order may directly conflict with either the provision of these Bylaws or the Constitution and Bylaws of the IAFC.

Section Ten – AMENDMENTS – A two-thirds majority vote of the eligible members present may amend these Bylaws at any regularly scheduled meeting of the Section by provided the Board of Directors, or a group formed of ten members of the section, has completed the following:

- 1. Documented the amendment
- 2. Distributed the amendment to the membership of the Section at least 30 days before the meeting at which it will be considered
- 3. Sent the amendment to the Chair of the IAFC's Constitution and Bylaws Committee at least 30 days before the meeting at which it will be considered
- 4. Received approval for the amendment from the IAFC Board of Directors
