# Call to Order and Chair's Welcome

Chief Mike McEvoy opened the meeting at 2 PM. He reviewed the meeting agenda and introduced the officers.

## Approval of the Minutes

Chief McEvoy asked for a motion to approve the minutes from last business meeting, which was held at FRI 2022.

Chief John Sinclair made a motion to approve the minutes, which was seconded by Chief Norris Croom, and was unanimously approved.

# **Announcement of Officer Appointments**

Upon elevation to EMS Section Chair, Chief Joles position as Secretary/Treasurer opened. Per EMS Section bylaws, the new composition of the EMS Section Board is below:

### **Reports of Officers and Committees**

- **Past Chair's Report** Chief McEvoy gave a brief update of the section's activities. The section hosted a virtual version of Fire-Rescue Med in May, which was well-attended. He thanked the section for the opportunity to serve as EMS Section Chair.
- Chair's/Secretary-Treasurer's Report Chief Joles reported that the EMS Section has 1,095 members. He also reported on the EMS Section's finances. As of June 30, the EMS Section had a carryover balance from 2022 of \$121,871. It had total revenue of \$28,231 and expenses of \$27,333 for a balance of \$122,769.

Chief Ken Riddle made a motion to approve the Treasurer's report, which was seconded by Chief Pete Lawrence, and unanimously approved.

Chief Joles also reported that Chief Norris Croom needed to be reappointed as International Director of the EMS Section.

Chief John Sinclair made a motion to reappoint Chief Croom as the International Director, which was seconded by Chief Vance Riley, and unanimously approved.

• Legislative Update – Ken LaSala, the IAFC's Director of Government Relations and Policy, updated the EMS Section members on federal legislative issues. He urged members to call their Representatives and ask them to pass the Fire Grants and Safety Act (H.R. 4090/S. 870). He also urged them to call their Senators and oppose proposed cuts to the Assistance to Firefighters Grant program, the SAFER grant program, and the U.S. Fire Administration. Mr. LaSala also urged members to ask their Senators and Representatives to cosponsor and pass the SIREN Grant Reauthorization Act (H.R. 4646/S. 265).

#### **Presentations from Liaisons and Guests**

- FirstNet Jon Olson from the First Net Authority discussed FirstNet's roadmap and strategic plan. The buildout is complete, so FirstNet is focusing on the next steps. It is reinvesting funds into the network and focusing on the use of technology and plugging operational gaps.
- **GAPB** Chief Pete Lawrence is a member of the federal Advisory Committee on Ground Ambulance and Patient Billing. He discussed the No Surprises Act, which created the committee and the committee deliberations. He explained the need to ensure that insurers pay the state and local rates for EMS service, and do not try to pass of costs as being "out-of-network. He also discussed the need for a paramedic to be considered as a practitioner to allow for reimbursement of treatment in place.
- **USFA** Chief Richard Patrick, the Director of the National Fire and EMS Division of the U.S. Fire Administration (USFA), updated the EMS Section members about changes at USFA. He said that the division is focused on fostering EMS prehospital systems; assessing state,

local, tribal, and territorial EMS agencies; and better integrating EMS into emergency management.

The key initiatives of the National Fire and EMS Division are:

- EMS Needs Assessment.
- National Response Framework Community lifeline.
- EMS Licensure COMPACT.
- Joint Federal Initiatives like the Federal Interagency Committee on EMS (FICEMS).
- Research and Technology (including working with NIH).

He reported that the National Fire Academy has 10-12 dedicated EMS programs. The USFA is preparing for a new U.S. Fire Administrator's Summit in October.

 NHTSA Update – Chief Dave Bryson, who serves with the Office of EMS of the federal National Highway Traffic Safety Administration (NHTSA), briefed the EMS section members. He reported on NHTSA's focus on the Safe Streets Program and on focusing on reducing fatalities of children in ambulance crashes. He also reported that FICEMS developed a COVID-19 EMS Response white paper. NHTSA also is updating the Education Agenda. He discussed the National EMS Advisory Council's (NEMSAC) statement on a graduate paramedic position.
