Committee Reports:

- Election
 - Positions up for election in 2022 -Navy, Coast Guard, Defense Logistics Agency, and the Marine Corps. - Fire Rescue International (24 26 Aug 22)
 - o Registration is now open

- Strategic Planning
 - o IAFC Phase II Strategic Planning meeting currently underway. The Section will review the IAFC goals and objectives and update current vision, mission, and goals of the Section. (Canale)
- Special Claim Handling Unit
 - o IAFC has created procedures to streamline administrative process to handle special claims and will continue to educate claims analysts. (McGee)
- Legislative Update (LaSala)
- PFAS Legislation

- According to the National Defense Authorization Act for Fiscal Year 2020, DOD has until January 2023 to publish a military specification for a PFAS-free firefighting agent for use at all military installations and to ensure that such an agent is available for use no later than October 2023. S.231, PFAS Act
- Summary: Requires the department of Homeland Security, in consultation United States Fire Administration, Environmental Protection Agency, the National Institute for Occupational Safety and Health to:
 - Develop and publish guidance for firefighters and other emergency response personnel on training, education programs, and best practices;
 - Make curriculum available that is designed to:
 - reduce and eliminate exposure to PFAS from firefighting foam and personal protective equipment;
 - o prevent the release of PFAS from firefighting foam into the environment; and
 - educate firefighters and other emergency response personnel on foams and non-foam alternatives, personal protective equipment, and other firefighting tools and equipment that do not contain PFAS
 - Create an online public repository, which shall be updated on a regular basis, on tools and best practices for firefighters and other emergency response personnel to reduce, limit, and prevent the release of and exposure to PFAS.
 - Status: Unanimously passed the Senate on July 30, 2021.
 - IAFC Position: The IAFC supports this bill. IAFC President Chief Kenneth Stuebing said the following when the bill passed committee: "This legislation will develop helpful guidance that local fire departments can use to reduce firefighters' and the general public's exposure to PFAS. Now that it has advanced through committee, I urge Congress to pass the PFAS Act as soon as possible."

o S. 3662, Preventing PFAS Runoff at Airports Act:

- Summary: Temporarily increases the federal cost share of PFAS testing equipment at part 139 airports to 100%. Part 139 airports are airports that: serve scheduled and unscheduled air carrier aircraft with more than 30 seats; serve scheduled air carrier operations in aircraft with more than 9 seats but less than 31 seats; and the FAA Administrator requires to have a certificate.
- Status: Passed the Committee on Commerce Science and Transportation on March 22, 2022

■ IAFC Position: The IAFC supports this bill. IAFC President Chief Kenneth Stuebing said the following when the bill was introduced: "It is crucial that airports have the resources necessary to extinguish fires safely and minimize the environmental impact of fighting these fires. The IAFC thanks Senator Peters for introducing this legislation, which will greatly assist airports in meeting both needs."

o H.R. 7597/S. 4076, PFAS Protection Act

- Summary:
 - Prohibition on Firefighting Foam Containing PFAS: Two years after the date of enactment, no person may manufacture, import, process, or distribute in commerce any aqueous film forming foam for use in training and firefighting that contains a per- or polyfluoroalkyl substance. A violation of subsection shall be considered a violation of the Toxic Substances Control Act
 - Deadline for PFAS Usage at Airports: Not later than October 5, 2024, the FAA, using the latest version of National Fire Protection Association 403, 'Standard for Aircraft Rescue and Fire-Fighting Services at Airports', shall prohibit the use of fluorinated chemicals in firefighting foam at airports'.
 - IAFC Position: The IAFC is still examining the bill and has yet to take a position on it.

o Fire Groups' Report on Fire Department Contamination

• Summary: The IAFC and other fire organizations are requesting a report from the EPA or GAO about the scope of PFAS contamination on fire department grounds and the cost of clean-up.

• Personnel/Administrative Issues

- o H.R. 2499/S. 1116, Federal Firefighters Fairness Act
 - Summary: The bill would grant a presumptive disability to federal firefighters for 16 illnesses, including various types of cancer, heart attack, stroke, and chronic obstructive pulmonary disease. There would be a process for adding other diseases.
 - Status: H.R. 2499 passed the House on May 11. S. 1116 passed the Senate Homeland Security & Governmental Affairs Committee on May 25.
 - IAFC Position: The IAFC endorsed both bills.
 - Administrative Actions: On April 20, the IAFF and the Department of Labor announced new administrative processes for federal firefighters:
 - Special Claims Handling Unit: The DOL will establish a special claims handling unit within OWCP to focus solely on federal firefighters' claims. The claims analysts in this unit will receive special training to understand firefighters' unique jobs

- and that non-traditional and non-fire ground injuries are still covered by OWCP.
- Cancer Coverage: DOL will establish new connections between the special claims handling unit and the National Institute for Occupational Safety and Health (NIOSH) to assess workers' compensation claims from firefighters suffering from cancer. Through these connections, NIOSH will use findings from the National Firefighter Cancer Registry and other projects to educate the special claims handling unit's staff on the service connections between firefighters' jobs and incidences of cancer. While the DOL is unable to unilaterally establish a cancer presumption, this new partnership will better educate OWCP staffers and should lead to more approvals of benefits for firefighters battling service-connected cancer.

o H.R. 521/S. 129, the First Responder Fair RETIRE Act

- Summary: This bill allows a federal first responder to remain in the accelerated retirement system if they are placed in another civil service position outside of that system after returning to work from a work-related injury or illness. Further, if such an employee is separated from service before they are entitled to receive an annuity, they may receive a refund of their accelerated contributions
- Status: H.R. 521 passed the House Oversight Committee and Reform Committee on May 11. No action has been taken in the Senate.
- IAFC Position: The IAFC has not taken a position on this bill this year.
