### **Chair Report**

Chief Julien Crolet for Chief Crutcher

Chief Crolet discussed the request that Chief Crutcher sent to Chief Robichaux for the IAFC Executive Committee to request the Minority Leader in the Senate to pass a Continuing Resolution in order to open and fund the government.

### **Treasurer's Report**

Chief Deemer provided a September Treasurer's report - \$908 income from dues, \$40166 beginning assets and \$41074 ending assets balance.

### **Legislative Update**

Mr. Ken LaSala

Mr. LaSala discussed the current situation with the federal government closure. The Senate takes up a vote today on the DoD and Health and Human Services appropriations bills. If it passes we will see if uniformed military fire service personnel will be paid. The IAFF has a productive working relationship with the Administration and may have opportunity to gain support for federal and military fire service members and departments.

### **Committee Reports**

Parentships and Supporter Committee – Chief Crolet reported that Chief Crutcher has two potential supporters and has reached out to both.

### **Business Agenda**

Chief Canale is proposing to revise the bylaws in the 2026 election cycle that allows for all members to cast ballots for Board candidates regardless of the branch or agency being filled. The proposal will be routed to Chief Deemer, Treasurer who will bring it forward for Board action at the December meeting. Bylaws change proposals for the 2026 election cycle will be due February 2026.

### **New Business**

Chief Crolet will request a meeting with Director Danny Gray, Membership with another Board member or two to discuss options for membership dues relief and report back at the December Board meeting.

Chief Crolet discussed three options for membership outreach to include either webinars, podcasts or Teams sessions (similar to the IAFC weekly COVID 19 Teams calls). An urgent topic is the government closure with possibly a series of updates and informative outreach discussions if the shutdown continues. There is also an interest in heightened social media presence. Kevin McGee requested any content starting now and he will also confirm if there is Section specific social media platforms.

#### **Old Business**

Chief Crolet will remind Chief Canale, Chief Goode and Chief Crutcher to submit their news articles for distribution to the membership.
