## **Reports from Officers:**

**Chair:** Chief Dahman addressed the membership advising them the IAFC Board of Directors will allow the Federal Military to remain a Section temporarily but the Section must continue to increase membership. Chief Dahman then presented a slide presentation reviewing section plans for the future and accomplishments for the past year. (See Attachment 1)

**Army:** Chief Gilgallon advised that budget constraints were having a huge impact on Army fire protection including apparatus, staffing and risk assessment visits. Chief Gilgallon is working on increasing USA membership. Recently met with Army Material Command Chiefs to discuss issues.

**Navy:** Chief Murray advised the membership that while still facing strict budget constraints USN is approving recruitments to fill vacant positions. Non Labor dollars are very tight on active duty side. Reserve side of the house currently has non labor dollars available.

**At Large:** Chief Mattingly reported the National Institute of Standards and Technology – Department of Commerce has a new fire chief, who he will be reaching out to. Additionally Chief Mattingly will be reaching out to the other federal fire chiefs in hopes of bringing them on board.

# **Committee Reports:**

<u>Election/Nomination Report:</u> IAFC Staff Liaison Gary Brouse presented the process for nomination and election following guidelines establish in section By-Laws. Reported all candidates nominated met requirements.

### **Election Results:**

- US Navy Representative: Fire Chief Paul Murray Unopposed
- US Coast Guard Representative: Fire Chief Chris Walters- Unopposed
- Defense Logistics Agency Representative: Vacant
- US Marine Corp Representative: Vacant

Mr. Brouse noted that Chief Walters has since resigned from the Board due to personal issues, creating a vacancy for the US Coast Guard seat

Chief Dahman extended his sincere appreciation on behalf of the Board to the outgoing board members Chief C.J Hipshire, Chief Ray Harvey and Chief Chris Walters.
