# **Reports from Officers:**

**Army:** (Chief Gilgallon)

- Army Material Command funded 2 positions to attend IAFC Fire Rescue International
- Staffing policy changes Army will only staff to 71% of required firefighters. Mutual aid will be relied on for the remaining.
- Working under defined Scope of Service effort to reduce overtime. Implemented restrictions on overtime limiting no more than 72 hours straight without a break.
- Re-purposing apparatus. Army HQ moving base apparatus around to other installations
- US Army Installation Management Command (IMCOM) Chiefs met at Ft Benning to discuss fire issues impacting IMCOM Chiefs.
- There is a concern at the fire chief level of lack of communication from Top Army down to the installations
- Army HQ has hired a Fire Protection Specialist (Mr. Davis)

#### **Navy:** (Chief Murray)

- Navy is also working under overtime restrictions of no more than 72 hrs then must take a 24 hr break.
- Awaiting 6055.6 re-write
- Navy region SE non- labor funds cut considerable 75%
- Currently there has been no restriction on hiring firefighters to fill authorized job openings.
- Navy Fire is relying heavily on mutual aid
- Activating USN Reserve firefighters to overseas assignments
- Active Shooter training and installation assessments have a priority
- USAF Reserve procured dual purpose PPE to do away with proximity clothing. Navy SE is looking at doing the same.
- Working on replacing the PFOS & PFOA in fixed systems

# **At Large:** (Chief Mattingly)

- Continue to recruit other services into the At Large portion of the Section
- NIH able to bring staff to IAFC Fire Rescue International
  - Working on accreditation
  - o Budget has been flat
  - o NIH FD able to procure apparatus
  - Healthcare costs has put NIH in a deficit.

### **USAF:** (Chief Canale)

- Chief Canale led a discussion on Mutual Aid & Ultra high pressure; He inquired if others are using it on mutual aid and how it was workings.
- Air Shows Questioned whether all services work under a similar Concept of Operations (ConOps) Engines running ready to go
  - o Fort Worth looking at moving air show off base for security reasons
- AFFF PFOS and PFOA issue USAF Enterprise wide phased out and turned in.

<u>Election/Nomination Report:</u> IAFC Staff Liaison Gary Brouse presented the process for nomination and election following guidelines establish in section By-Laws. Reported all candidates nominated met requirements.

#### Legislation

H.R. 1363, Allows federal firefighters to swap shifts outside the two-week pay period.

H.R. 1884, the Federal Firefighters Fairness Act – Grants presumptive disability to federal firefighters for heart disease, lung disease, tuberculosis, hepatitis, human immunodeficiency virus, and specified cancers. SB 29, the Federal Firefighter Pay Equity Act (Introduced by Rep. Gerry Connolly (D-VA)) – Allows the 19 hours of overtime hours each week in a firefighter's 72-hour week to be accounted for when computing the firefighter's

#### Budget

• OGR tasked with coming up with at least \$32 billion in cuts to federal retirement or health benefits over the course of a decade.

- o Increase amount paid in to retirement
- o Ending FERS annuity supplement
- o High 5 vs 3

retirement benefits

- o Reduce COLA's for current and future (CSRS) retiree's
- o Eliminate future COLA's for current and future FERS retiree's
