## Rural Emergency Response Planning Demonstration Project

- The goals of the project include:
  - looking at the types of hazardous materials being transported through the selected jurisdiction with a focus on rail.
  - looking at the historical record of hazmat incidents that have occurred, to determine what hazmat response capabilities are in place.

- identify gaps in the local response plans, and to provide a resource guide for the jurisdiction.



## Over the past two years

- The IAFC has been in the forefront in developing training for alternative fuels response. We have partnered with federal agencies, such as PHMSA, the U.S. Fire Administration, and the U.S. Department of Energy, and organizations such as the Ethanol Emergency Response Coalition and the National Biodiesel Board, to develop training materials for incidents involving ethanol and biodiesel. The instructor guides, participant manuals, PowerPoint presentations and DVDs are designed to be easy-to-use and readily accessible for fire departments and other hazmat responders in their effort to acquire up-to-date information on strategies, tactics, and even the types of foams that need to be used.
