Chair Report

Chief Rich Cowger

Secretary Treasurer Report

Chief Windisch presented the Treasurer's report reviewing the last financial statement he received for February 2025. He reported that the Section is in good financial position.

Strategic Plan

Technical Advisory Program (TAP) Report

TAP will change to C2C (Chief to Chief). C2C will be established in a way so that it complements ESCI and not compete.

Chief Kevin Cooney stated that the National Fallen Firefighters Memorial Weekend was well attended with 144 Firefighter Line of Duty Deaths were honored with family, friends, fire service members and honored quests in attendance.

Chief Cooney reported on the FEMA Taskforce as an opportunity to identify changes, programs and services that can be shared with the Administration. The Taskforce has 10 members and meets every other Tuesday. The Taskforce is reviewing Presidential Directives that affect the fire service.
