Welcome and Agenda Overview - Chief Wall

Chief Wall started the meeting.

Motion by Chief Flynn and seconded by Chief Larson to approve the minutes from the May board meeting. Motion carried. Chief Rush abstained since he wasn't there.

Chief Chris Christopoulos (career) and Chief Byron Andrews (volunteer) were submitted as the VCOS nominees for Fire Chief of the Year.

Kidde Program - Chief Flynn

• Cancer initiatives – Chief Seavey reported that the NVFC has their annual training summit where they talked about cancer issues. An idea was brought up to have a national conference on cancer in the workplace. After further investigation, the NVFC found out that is part of the cancer alliance's plan already. Another idea is to have the younger generation speak to the younger generation through short videos about cancer prevention. There is a request for \$1,000 for video equipment to do these videos to ship to different departments. Chief Buckman will then edit videos. He will coordinate shipping the equipment to several board members.

Motion by Chief Seavey and seconded by Chief Flynn to have the executive committee move forward with the cancer video project and funding request. Motion carried.
