#### **Partnerships - Chief Wall**

• Near Miss – Chief Wall will get clarification on the proposal that was attached to the April agenda. There was a question of rewarding bad behavior. What is the criteria for choosing scholarship recipients? Who will manage the scholarship? What is the application process? Chief Windisch suggested that the scholarship be a one-time only award. (Ms. Laura Bell is the staff manager for Near Miss.) Chief Dan Kerrigan and Chief Eddie Buchanan should have more information. It was suggested that the award be given to the department/person who can provide a tangible program developed to eliminate a near miss issue. The award could be given out at the Symposium General Session or at a breakout session. Chief Collins will find a time in the Symposium schedule. Action item: Chiefs Wall
