# **Report from Officers:**

- Navy
  - o ARFF vehicles being rebuilt and returned; Overall good quality and performance
  - Southeast Region has a lot of activities with IG going on primarily overtime & uniform issues
  - o Reserve units still have funding/ Active duty money tight
  - o Training money is available but no conference money
  - o Labor Management Training being held in the region titled "the Uncivil Servant"
- USA
  - Met with Mr Staub, new Chief-Army Fire and Emergency Services at OSD
  - o Army having challenges with staffing
  - o Currently underfunded for apparatus; will not be able to fully fund until 2019
  - o Able to fill existing position but no new positions
  - o Continuing slow response from HR to fill positions
- HHS
  - o Overall things are stable with minimal issue(s)
  - o NIH receiving a new engine and working on the specifications for a new ambulance
  - Standing up a new emergency management position at HHS's Research Facility in Montana;

#### **Old Business:**

- Membership
  - o Chief Brouse- Will be updating the website and preparing eblasts to go out to potential members, KnowledgeNet
  - Chief Gilgallon and Chief Brouse met with Mr Monroe prior to the teleconference about the possibility of using KnowledgeNet as a communication tool for Fed Mil partners.
    - Mr Monroe was willing to provide non members a 6 month membership to provide access to KnowledgeNet for Federal Military communications
  - o Reviewed existing members that have affiliation with DoD; will be sent a letter to join Section
- Recruitment (DLA,
  - O Chief Don Rodgers was approved by the Board as the DLA representative replacing Chief Kenneth Pence.
    - On behalf of the Board we thank Chief Pence for his willingness to be a part of the Board and wish him well.

- CFSI

- Legislative Issues

- o Two primary legislative issues that are being pursued by the Section are as follows:
  - Use of Government Purchase Card for food and water during emergencies and deployments. Needs to be all encompassing to include other Federal first responders (eg. NIH and Law Enforcement)
- Use of Federal Fire Apparatus for Funeral processions both Line of Duty and close associates
  - NIH vehicles used as "incidental use"
- o IAFC monitoring and supporting legislative provision on Federal Special Retirement No TSP penalty for withdrawal under age 59 1/2

#### **New Business:**

- Chief Dahman suggested a possible letter from the IAFC President to OSD in regards to support at Fire Rescue International
- DoD Fire and Emergency Services and Working Group (DoD FESWG) Meeting; Chief Dahman reported that the DoDI 6055.6 is under rewrite and may take some time
- Chief Brouse reported the Foundation was out of Federal Military Commemorative Coins; Chair asked for new quote and send out to Section for discussion and possible approval
